This cupboard was in a room that was locked during the day however for a short period it had been accessed by a patient. The practice staff took steps when this had been brought to their attention and the cupboard was secured. Following the inspection, the practice told us that this incident had been reviewed and measures put in place to minimise the risk of a reoccurrence.</p>

Medicines error	On reviewing the repeat prescription for a patient, it was discovered that they had been place on a medicine that was not appropriate for their clinical circumstances. The GP declined to authorise the repeat and arranged a face to face consultation where the patient received a full explanation and an apology. An appropriate medicine was prescribed and the incident was discussed at the practice meeting. Further guidelines for clinicians were shared and an audit of patients prescribed the medicine was undertaken.

- The practice followed up on older patients discharged from hospital. It ensured that their care plans and prescriptions were updated to reflect any extra or changed needs.
- Staff had appropriate knowledge of treating older people including their psychological, mental and communication needs.
- Health checks were offered to patients over 75 years of age.

People with long-term conditions

Findings

- Patients with long-term conditions had a structured annual review to check their health and medicines needs were being met. For patients with the most complex needs, the GP worked with other health and care professionals to deliver a coordinated package of care.
- Staff who were responsible for reviews of patients with long-term conditions had received specific training.
- GPs followed up patients who had received treatment in hospital or through out of hours services for an acute exacerbation of asthma.
- The practice could demonstrate how they identified patients with commonly undiagnosed conditions, for example diabetes, chronic obstructive pulmonary disease (COPD), atrial fibrillation and hypertension.
- Adults with newly diagnosed cardio-vascular disease were offered statins.
- Patients with suspected hypertension were offered ambulatory blood pressure monitoring.
- Patients with atrial fibrillation were assessed for stroke risk and treated appropriately.

An audit to assess the initiation and monitoring of a group of anticoagulants resulted in a significant improvement in the completion of full baseline blood tests over the course of the study, raising from approximately 11% to 83%.

An audit of the prescribing of strong oral opioids found that the practice clinicians were prescribing broadly in line with the National Institute of Clinical Excellence (NICE) guidelines. Further suggestion from this audit to monitor those patients with dependency were in place.

- The needs of this population group had been identified and the practice had adjusted the services it offered to ensure these were accessible, flexible and offered continuity of care.
- The practice was open until 8pm on a Thursday and Friday as part of the local hub. Pre-bookable appointments were also available to all patients at additional locations within the area, as the practice was a member of a GP federation. Appointments were available on Saturday at the branch surgery and at other local GP practices as part of the local GP hub.
- The practices provided a GP phone consultation when a face to face appointment was not required.
- Patients could access results via the practice telephone system to reduce the need to take time off to visit the surgery.

People whose circumstances make them vulnerable

Population group rating: Good

Findings

- The practice held a register of patients living in vulnerable circumstances including homeless people, travellers and those with a learning disability.
- People in vulnerable circumstances were easily able to register with the practice, including those with no fixed abode.
- The practice adjusted the delivery of its services to meet the needs of patients with a learning disability. Annual reviews were undertaken for patients on learning disability register and there was a flexible approach to where the reviews were carried out. For example, patient had a choice of at home or in the surgery to reduce stress.
- The practice care co-ordinator worked with individuals to support them with information, signposting and follow up. We saw information to confirm the care co-ordinator and practice clinicians had worked with other agencies to develop intervention strategies for people with complex health and social care needs.

People experiencing poor mental health (including people with dementia)

Findings

- Priority appointments were allocated when necessary to those experiencing poor mental health.
- Staff interviewed had a good understanding of how to support patients with mental health needs and those patients living with dementia.
- The practice was aware of support groups within the area and signposted their patients to these accordingly.
- The practice told us they plan to become a dementia friendly practice. The practice manager was booked on Induction session in May 2019.
- The practice offered same day appointments/phone triage for patients with acute mental health concerns.

Notes: CQC GP Insight

GP Insight assesses a practice's data against all the other practices in England. We assess relative performance for the majority of indicators using a "z-score" (this tells us the number of standard deviations from the mean the data point is), giving us a statistical measurement of a practice's performance in relation to the England average. We highlight practices which significantly vary from the England average (in either a positive or negative direction). We consider that z-scores which are higher than +2 or lower than -2 are at significant levels, warranting further enquiry. Using this technique we can be 95% confident that the practice's performance is genuinely different from the average. It is important to note that a number of factors can affect the Z score for a practice, for example a small denominator or the distribution of the data. This means that there will be cases where a practice's data looks quite different to the average, but still shows as no statistical variation, as we do not have enough confidence that the difference is genuine. There may also be cases where a practice's data looks similar across two indicators, but they are in different variation bands.

The percentage of practices which show variation depends on the distribution of the data for each indicator, but is typically around 10-15% of practices. The practices which are not showing significant statistical variation are labelled as no statistical variation to other practices.

N.B. Not all indicators in the evidence table are part of the GP insight set and those that aren't will not have a variation band.

It is important to note that z-scores are not a judgement in themselves, but will prompt further enquiry, as part of our ongoing monitoring of GP practices.
